

Please find below the details and procedures of our After School Care (ASC) programme for the upcoming 2025-2026 school year.

Aim and Purpose

ISU After School Care is an additional offering intended for parents of ISU students who are working and therefore cannot pick up their child at the respective end of the students regular school day.

The purpose of ASC at ISU is to provide on campus supervision by creating a safe, structured, and enjoyable environment for the children after their regular school hours.

Availability

ISU After School Care is only available for children that are students at ISU in the grades EY 1 to Grade 5.

Registration for ASC is necessary in all cases. Without a registration for ASC the students **cannot** attend. The first day of ASC for the school year 2025-26 will be 25th August 2025.

Days where ASC will not be available:

- All school holidays
- ParentTeacher Conferences
- Days before Winter and Summer Holiday with early closure at 1pm.

Days & Times for EY 1- 3

Monday to Thursday:

- 15:00 - 16:00
 - Free of charge, if a student has a sibling in Grade 1 or above
 - Available with a fee for all other EY students
- 16:00 - 17:00 Available with a fee for all

Fridays:

- 12:30 - 14:00 Free of charge
- 14:00 - 16:00 Available with a fee

Days & Times for Grade 1 - 5

Monday to Thursday:

- 16:00 - 17:00 Available with a fee

Fridays:

- 12:30 - 14:00 Free of charge
- 14:00 - 16:00 Available with a fee

Pick up from ASC

Pick up from After School Care will be possible at designated times based on the times the students have been signed up for. Pick-up is always on the hour, except Friday: pick-up only at 14:00 or 16:00 (depending on times booked).

The designated pick-up times will make it possible for ASC staff to organise games with the students without being interrupted.

The students will be brought to the playground entrance (next to parking) automatically based on registered times.

For example:

EY student registered on Monday from 15:00 - 16:00 -> pick up at 16:00

Grade 4 student registered on Friday until 14:00 -> pick up at 14:00

All students EY 1 – Grade 5 registered on Friday until 16:00 -> pick up only at 16:00, no possibility to pick-up at 15:00

Terms & Conditions

ASC fees are non-refundable. This includes closure of the school due to force majeure or for example, the result of extreme weather conditions. The same applies to the short or long term suspension or (final) expulsion of the student and the ensuing termination of the contract with ISU.

Based on registration numbers for ASC ISU has the right to determine a maximum of students per day. In this case the full year sign-ups will have priority.

Further terms and conditions will be mentioned in the registration form for ASC.

Fees for payable After School Care Grade 1 - 5

Registration for full year 25-26 (ASC from 25th August 25 – 1st July 2026) :

Every day of the week	1.863€
Only certain days Mo - Thu 16:00 - 17:00	320€ per day
Only Fridays 14:00 - 16:00	640€

Registration for 4 weeks during 25-26:

Every day of the week	210€
Only certain days Mo - Thu 16:00 - 17:00	35€ per day
Only Fridays 14:00 - 16:00	70€

The four weeks always start on Monday and do not include school holidays.

Registration for ASC

Please note that registration for ASC is necessary in all cases, regardless if free of charge or payable. The link to the registration form will be available as of 16th August via the ISU website is-ulm.de. Registrations for access to ASC starting on 25th August must be completed by August 21st at the latest.
